Topic Co-Shaping the Future of IGBCE

An eventful year is drawing to a close. The best thing for you: KAAT.net has become even better anchored and established in the IGBCE in 2024. This means that your topics will be given even greater consideration – now and in the future. The turn of the year is always an opportunity to look back, but also to look ahead. And there is a lot going on in the IGBCE in 2025 (not only) from a KAAT perspective: IGBCE's 8th Ordinary Trade Union Congress (Ordentlicher Gewerkschaftskongress, OGK) will take place in Hanover in October.

The OGK is the highest body of our organization. Every four years, over 400 delegates from all districts vote on proposals from all over Germany and all sectors. Decisions are also made on appointments to numerous functions, including the Executive Board. This means: The OGK makes forward-looking decisions for the union. IGBCE is organized democratically from the bottom up: All members can contribute their ideas and propositions at any time in the shop stewards' committees (Vertrauensleutegremien) and general meetings (Mitgliederversammlungen) of the companies. Many of these ideas are then presented at district and regional conferences and formulated into motions. The delegates then discuss and vote on these motions at the congress.

A Clear Start into the New Year

Participation is a top priority for IGBCE. The union has launched the "KLAR - Clear for the Future" strategy process so that not only the delegates at the union congress can have their say. It deals with the positioning of the union in the five central strategic action fields of industrial, transformation, social, collective bargaining, labor and company policy. Members are involved in various ways, e.g. via an app survey – with record participation, by the way! – , via industrial policy symposia in the regional districts and via the digital future workshop. Around 35,000 members (all those who are active in at least one committee) were invited to contribute their perceptions and ideas on 20 November. The results of this dialogue are incorporated into the district delegates' conferences as a basis for discussion. In this way, the delegates' decisions are based on the perspectives of many.

Service Co-determination at IGBCE level

"Bringing ideas and proposals to the congress" - What does that mean in concrete terms? As an IGBCE member you have the opportunity to bring your issues to the shop stewards' or members' meetings of your company. The elected representatives from our companies then take the motions to the respective district delegates' conference. These conferences will take place from the end of January 2025. There the motions are discussed and, if passed, forwarded to the respective regional delegates' conference (from the beginning of May), and from there to the trade union congress in October.

The district of Ludwigshafen is breaking new ground: on St. Nicholas Day (December 6), a KAAT target group conference was held there for the first time. All KAAT members from Ludwigshafen had the opportunity to take part and discuss their issues. Some controversial discussions took place and the participants voted several times. The members decided to initiate several motions. One demands that the collective agreements of a sector should apply to all members in this sector. Another calls for a clear positioning towards the collective agreement for academics in the chemical industry (MTV Akademiker Chemie).

Legal Going on vacation despite illness?

Gray, foggy, cold and wet. Germany can be pretty uncomfortable in winter. That's why many people like to fly south for a week or two - in the middle of the flu season. Some people ask themselves: What happens if I fall ill before I start my trip? Can I still travel anyway?

The good news is that employees are generally allowed to take a planned vacation despite being on sick leave. However, they must make sure that the vacation serves its true purpose: recovery. Anyone thinking he*she has to climb high Alpine peaks with a feverish respiratory illness is, in case of doubt, in breach of their duty of care towards themselves.

The rule of thumb is: if a trip could jeopardize your recovery, it should not be undertaken. Because this leaves room for interpretation, it is advisable to involve the attending physician in the decision. He or she can document the trip as medically justifiable. So that nothing remains of the long-awaited vacation but fond memories.
